Fund Selection Methodology

Independent research is conducted (applying a rigorous quantitative and qualitative process) to rate the universe of funds (in excess of 900) to make available an approved Linked Range of funds on the platform.

Step 1 - Initial Rating

The quantitative process is a return -based analysis that is based on weighted scores of two periods, three years (short term) and five years (long term). A combined rating is determined by using a 40% weighting to the short term and 60% weighting to the long term by way of STANLIB Multi-Manager’s quantitative rating model. Questions that are asked include: Did the fund outperform and how consistent was this performance; what risk was assumed to achieve the returns and were the returns achieved from avoiding market “bears” or riding market “bulls”; and lastly, how does the performance rank relative to its peers. The funds are all given an initial “Buy”, “Hold” or “Sell” rating.

Step 2 - Qualitative Overlay

The qualitative process entails the assessment of manager fundamentals and aims to assess the repeatability and “quality” of the returnbased analysis in Step 1. This includes all the funds on the “Buy” and “Hold” lists, but may also selectively include some of the funds on the “sell” list, which over the short term demonstrated a positive trend or “turnaround” in performance numbers. The process applies a number of selection criteria such as investment philosophy, process, people, culture and leadership, as part of the qualitative overlay.

Step 3 - Final Rating

The initial quantitative ranking in conjunction with the qualitative overlay result in a final fund (star) rating. Funds with a two star rating or higher qualify for the next step in the process.

Step 4 – Business Overlay

The business overlay takes into account ASISA Retail Flows, Manco AUM (ASISA and STANLIB Linked Investments) and Manco Fund Marketing Strategy and Footprint.

The Final STANLIB Linked Range Fund List

The final STANLIB Linked Fund Range is determined based on the Final Star Rating together with the Business Overlay.
