What is the fund's objective?

The fund aims to maximise long-term total returns.

What does the fund invest in?

The fund invests in shares of the STANLIB Global Balanced Fund, which in turn invests in a combination of liquid global stocks and securities across sectors and geographies. The fund may vary the ratio of stocks and securities to maximise capital growth and investment returns in changing economic environments. The fund will have minimum foreign exposure of 85%.

What possible risks are associated with this fund?

This fund is part of STANLIB's risk-profiled range of international investment options. The possible risks associated with this fund include general market and economic risk such as exchange-rate fluctuations and geographical risk in that it includes funds held globally. Total Expense (TER): This ratio shows the charges, levies and fees relating to the management of the portfolio and is expressed as a percentage of the average net asset value of the portfolio, calculated over the period shown and annualised to the most recently completed quarter. Transaction Costs (TC): This ratio shows the percentage of the value of the fund incurred as costs relating to the buying and selling of the fund's underlying assets. TC are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, investment decisions of the investment manager and the TER.

Total Investment Charges (TIC): This ratio is simply the sum of the TER and TC, showing the percentage of the value of the fund incurred as costs relating to the investment of the fund. It should be noted that performance figures account for all costs included in the TIC ratio, so you should not deduct the TIC from performance figures, the performance is already net of the TIC.





