What is the fund's objective?

The fund's main objective is to provide a diversified portfolio that delivers a reasonable level of capital growth over the longer term.

What does the fund invest in?

The fund invests in a mix of equity and non-equity securities. Equity exposure is capped at 75% of the portfolio. The fund invests in South African and foreign investment markets, up to the limits allowed by the ASISA South African Equity-General classification.

What possible risks are associated with this fund?

General market risks include unfavourable market movements, volatility, economic and political risk, and company-specific risk. Where exposure to foreign investments is included in the fund, there may be additional risks, such as possible constraints on liquidity and the return of funds to South Africa, macroeconomic risks, political risks, tax risks, settlement risks, and possible limitations on the availability of market information.

Total Expense (TER): This ratio shows the charges, levies and fees relating to the management of the portfolio and is expressed as a percentage of the average net asset value of the portfolio, calculated over the period shown and annualised to the most recently completed quarter. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER should not be regarded as an indication of future TERs.

Transaction Costs (TC): This ratio shows the percentage of the value of the fund incurred as costs relating to the buying and selling of the fund's underlying assets. TC are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, investment decisions of the investment manager and the TER.

Total Investment Charges (TIC): This ratio is simply the sum of the TER and TC, showing the percentage of the value of the fund incurred as costs relating to the investment of the fund. It should be noted that performance figures account for all costs included in the TIC ratio, so you should not deduct the TIC from performance figures, the performance is already net of the TIC.

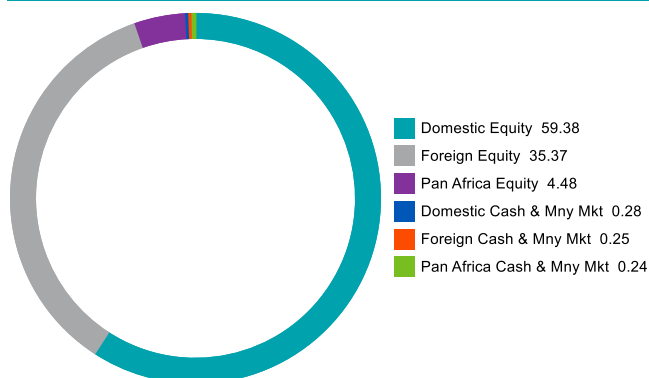

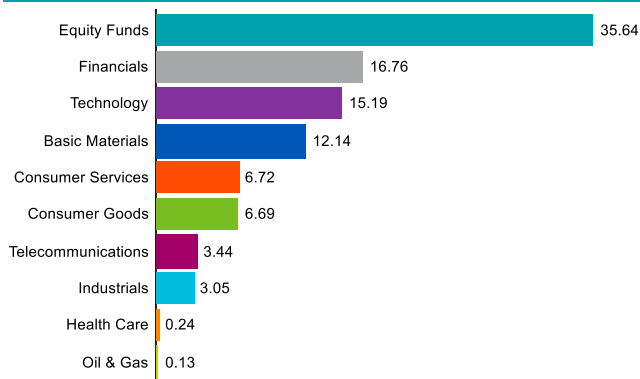
Asset allocation (%)

In 2007 Herman joined a private equity company as a deal originator to expand his investment skillset. He later in 2009 re-joined STANLIB as the head of Balanced funds. He oversees a number of portfolio managers and analysts who provide company research and actively pursue investment ideas. Under his leadership, the team reviews and refines opportunities which are considered for the portfolio. Herman holds a bachelor of engineering from the University of Pretoria and a MBL from UNISA.

Theo is currently a portfolio manager in the equity team and has been with STANLIB since 1999. Theo is a highly experienced industry professional who was previously head of the Industrial Research team at STANLIB, with direct research responsibility for the luxury goods, food manufacturing, hospitals and pharmaceutical sectors. Prior to joining Liberty Asset Management as a research sector head in 1999, Theo had spent nine years with UAL/NIB Asset Management in various research and fund management positions. Theo completed his BCom honours degree in 1989, majoring in investment management, and he has been a CFA charterholder since 1994.

Fund review

The STANLIB Equity Fund delivered an 1.81% return for Q4 2019 compared with a benchmark (FTSE/JSE SWIX All Share Index) return of 4.8%. The one-year return for the fund is 10.42% compared with the benchmark return of 9.3%.

Exposure to emerging market equities and SA contributed positively to the performance of the fund. Global equities detracted from performance, partly due to a stronger rand during the period.

Within SA, the contributors to the relative performance of the fund were our overweight exposures to Northam, Capitec and Dischem and underweight positions in Telkom, Woolworths and ABSA. Overweight positions in ABInbev, Prosus and MTN and underweight positions in Platinum and Gold shares detracted from performance.

Within the Africa component our exposure to Kenyan banks and telecoms added to performance while our exposure to Egypt detracted from performance.

Our offshore holdings in NVIDIA, a leader in artificial-intelligence computing, Microsoft and managed-care enterprise Centene led returns, after winning a contract in Texas and announcing healthy quarterly results contributed to performance. Detractors were no holdings in Apple and overweight consumer goods business Unilever.

During the quarter, we exited our positions in Glencore, African Rainbow Minerals and Curro and reduced our exposures to Capitec, Northam, Sasol and IHS Markit. We used the proceeds to build an overweight position in Anglo American and ING Group.

Market overview

The FTSE/JSE SWIX All Share Index's total return for Q4 2019 was 4.8%, outperforming SA bonds (1.7%) and SA cash (1.7%) over the short term. SA Industrials delivered no return during Q3 whilst SA Financials and SA Resources gained 2.8% and 13.8% respectively.

Over the one-year period to 31 December 2019, the FTSE/JSE SWIX All Share Index delivered 9.3%, with Resources remaining the best performing sector (28.5%) for the year. Financials remain the laggard at 0.6%. Industrials gained 8.9%.

Global equities delivered stellar performance during the quarter, with the MSCI World Index up 8.7% (in US dollar terms). The MSCI Emerging Markets Index gained 11.9% while the MSCI South Africa increased by 13.2% during the quarter.

Looking ahead

The global backdrop for markets remains linked to the China-US trade war and investors have reacted positively to the phase one deal. While this is clearly a step forward, we continue to anticipate both positive and negative surprises, given the intermingling of issues such as deficit reduction, market access, intellectual property and industrial policies being somewhat more positive than a quarter ago. The US and China seem ready to sign a trade deal and the US economy is ticking along nicely. Brexit is a certainty and now needs implementation.

Emerging markets should continue to benefit from the Fed's dovish stance and China's domestic stimulus.

In SA, we believe that the economic conditions for a number of SARB rate cuts are good and this can add some impetus to the local economy. This view is somewhat tempered by the constraints that the National Treasury is experiencing, and the possibility of selected tax hikes will be negative for consumers. The continued impact of Eskom loadshedding and drought conditions in selected areas remains a concern in the short and medium term.

This asset class offers investors an attractive opportunity into quality businesses locally and internationally, supported by global structural growth trends. There are many self-help opportunities to increase profitability, acquisition earnings to boost bottom line profits and ultimately grow the SA market's earnings base in 2020.
