#### What is the fund's objective?

The fund's primary objective is to be a vehicle for large cash balances which need to remain liquid for operational reasons. It provides cash management with a conservative bias.

#### What does the fund invest in?

The fund invests in major banking groups or similar rated institutions. Certain government issuances as well as issuances from top-rated corporations are included in the investment universe. The portfolio manager invests in various liquid assets, namely Treasury Bills, Bankers' Acceptances, NCDs etc. In line with Namibian regulations, at least 45% of the assets of the portfolio are invested in Namibia, with a maximum foreign (excluding South Africa) exposure of 35%. The maximum length of time to maturity of any individual asset is limited to a maximum of 36 months and the weighted average duration of the portfolio is limited to a maximum of 180 days.

#### What possible risks are associated with this fund?

The possible risks associated with this portfolio include general market and economic risks, such as interest rate and geographical risk.


