What is the fund's objective?

The fund's primary goal is to earn as much current income as is consistent with capital preservation and liquidity. Capital gains will be incidental. Clients benefit from wholesale cash management yields at competitive fees.

What does the fund invest in?

The Standard Bank Namibia Money Market Fund invests in five major banking groups or similar rated institutions. Certain government issues as well as issues from top-rated corporations are included in the investment universe. In line with Namibian regulations, at least 45% of the fund's assets are invested in Namibia. The fund only invests in government and corporate debt securities and in various liquid assets: Treasury Bills, Bankers Acceptances, NCDs, etc.

What possible risks are associated with this fund?

Possible risks include general market and economic risks, such as interest rate and geographical risk. The fund invests in a wide range of government and corporate debt securities in Namibia and SA with numerous institutions in various industries, which reduces its risk.



Prices are calculated and published on each working day, these prices are available on the Manager's website (www.stanlib.com/Namibia) and in Namibian printed news media. This portfolio is valued at 12h00. Forward pricing is used. Investments and repurchases will receive the price of the same day if received prior to 12h00.

This portfolio is a Money Market portfolio. A Money Market portfolio is not a bank deposit account. The price of a participatory interest is targeted at a constant value. The total return to the investor is made up of interest received and any gain or loss made on any particular instrument and in most cases the return will merely have the effect of increasing or decreasing the daily yield, however, in the case of abnormal losses it can have the effect of reducing the capital value of the portfolio. The yield (if shown) is a current 7-day average effective yield calculated daily. Excessive withdrawals from the portfolio could place the portfolio under liquidity pressures and, under such circumstances, a process of rein-fencing of withdrawal instructions and managed pay-outs over time may be followed.

All performance returns/figures quoted are shown in NAD and are based on data sourced from Morningstar or Statpro and are as at 31 December 2023.

Annualised return figures are the compound annualised growth rate (CAGR) calculated from the cumulative return for the period being measured. Portfolio performance figures are calculated for the relevant class of the portfolio, for a lump sum investment, on a NAV-NAV basis, with income reinvested on the exdividend date. Portfolio performance accounts for all costs that contribute to the calculation of the cost ratios quoted, all returns quoted are after these costs have been accounted for.
